Boarding Agreement (small and large dogs)

Boarding is overnight stays for small dogs and dogs with head heights not over 48 inches. Charges are calculated in 24 hour increments and hourly on pick-up days after the 24 hour period (+\$1.00/hour). Pawsome Suites, Inc. will provide quality and reasonable care for dog's left at their facility. Dog monitoring is facilitated by video surveillance. We cannot monitor all dogs continuously.

The following is a contract between Pawsome Suites, Inc. and the dogs' owner/owners.

1. Consultations are required prior to boarding and are by appointment only. Consultations are an opportunity for Pawsome Suites, Inc. and dog owners to evaluate the dogs. It gives everyone, especially the dog, an opportunity to familiarize itself with the environment. All dogs must be non-aggressive in playtime and not food or toy aggressive. Consultations are free.
2. All dogs must be up to date with vaccinations (DHLLPPv, Bordetella, and Rabies. Proof of veterinary administration is required. (no home vaccines accepted). We require copies .
3. All dogs must be spayed or neutered and at least 6 months of age.
4. All dogs should be in good health and owners must certify that dogs are free and have been free of communicable illnesses for at least 30 days.
4. We do administer medications. Please include these instructions on your pet's chart. We do not administer vaccines.
5. We do require emergency/ alternative contacts for emergencies and/or evacuations.
6. Please bring your dog's food, supplements, meds, treats, puppy pads, etc. Food should be in a plastic closeable container. Please pre-measure your dog's food servings (you can use plastic baggies). This is how we monitor regular food intake.
7. You may bring your dogs' toys, bed, special belongings, etc. Please have them labeled and we are not responsible for the condition in which they are they are returned .
8. We supply cots, food bowls, and water bowls.
9. We can't board dogs with head heights above 48".

10. All dogs must be leashed upon entering/ exiting the property and in the lobby. No retractable leashes (they break). Dogs should also have tags and retractable collars.

11. All dogs must be on flea prevention (oral or topical). Dogs will be checked for fleas at consultation. Any dogs found to have live fleas upon boarding will be administered Capstar at a fee of \$10.00 per dose.

12. Each individual pet is required to have an up-to-date Pet Chart. (this is forms separate from this agreement; it is on the website).

13. Reservations are required.

14. All owners must sign this contract limiting liability and allowing Pawsome Suites, Inc. the power to seek and/or administer any medical care deemed necessary especially in case of emergency (even if required by a veterinarian) at the owner's expense. Pawsome Suites will attempt to contact the owner or owner representative prior to treatment.

15. By signing this contract and providing the Pet Profile; the owner agrees to the information and policies supplied herein. The owner also certifies that all information provided is true and up-to-date.

16. All payments are required at pick-up. Dogs will not be released until all fees are paid in full. We accept cash, checks, credit, and debit cards.

Fees for Service:

1st dog- \$20.00 20% discount each additional dog

*7th day free

-charges are calculated in 24hr. increments and additional charges are added at \$1.00 per hour after the first 24 hours.
