## Daycare & Day Boarding (Small Dogs)-Agreement

Hours: Monday-Friday 6:00 a.m. – 7:00 p.m.

Saturday & Sunday 7:00 a.m.-7:00 p.m.

Daycare is for small social dogs. It is an opportunity for dogs to play and interact with other dogs. Dogs are grouped by temperament, size, and activity levels. Reservations are required.

Day Boarding is for dogs that are unsocial or too aged to participate in daycare. Yet their owners need assistance with day sitting. Reservations are required.

The following is a contract between Pawsome Suites, Inc. and the dogs' owner/owner:

1. Consultations are required for Daycare and Day boarding. Consultations are an opportunity for Pawsome Suites, Inc., and dog owners to evaluate the dogs. It gives everyone, especially the dog an opportunity to familiarize itself with this environment. All dogs must be social and non-aggressive in playtime. Consultations are by appointment only and are free.
2. Prior to attending Daycare/Day boarding, dog(s) must be up-to-date with vaccinations (DHLPP, Bordetella, and Rabies). All vaccines must be administered by a veterinarian and proof is required.
3. All dogs must be on oral or topical flea preventative. Dogs will be examined for fleas at the consultation. Any dogs found to be flea infested during their stay will be administered Capstar at a fee of \$10.00 per dose.
4. All dogs must be spayed or neutered and at least 6 months old to participate in Daycare/Day boarding.
5. All owners must sign this contract limiting liability and allowing Pawsome Suites, Inc. the power to seek and/or administer any medical care necessary especially in case of emergency at the owners expense. This includes veterinary care and/or consults. Pawsome Suites will attempt to contact the owner or owner representative prior to treatment.
6. Owner agrees to pay all costs and charges from the time of check-in. Owner further agrees that the pet shall not leave until all charges are paid. (accepted payments-check, cash, debit, credit)
7. All dogs must be leashed upon entering/ exiting the property and in the lobby. No retractable leashes (they break). Dogs should be tagged and have quick release collars.
8. Each individual pet should have an up-to-date Pet Chart/ Agreement. (these forms are on the web-site).

9. By signing this agreement and providing the Pet Chart, the owner agrees to the information and policies supplied herein. The owner also certifies that the information provided is true and up-to-date.

10. Reservations are required. No drop-offs.

11. The owner agrees that Pawsome Suites and its staff and volunteers will not be held liable for any problems or injuries that may occur while the dog is in the care of Pawsome Suites, Inc., provided reasonable care and precautions are followed by the Pawsome Suites, Inc. staff, and that Pawsome Suites, Inc. liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per animal boarded. Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Pawsome Suites, Inc.

9. This Agreement contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner /Owners and Pawsome Suites, Inc.

10. Payment is required at pick-up. Owner agrees that pet will not leave until all fees are paid. If the Owner does not pick-up the pet within 5 calendar days after the day the pet was due to be picked up, the pet shall be deemed to be abandoned ( unless other arrangements have been made in writing) and necessary steps will be taken to turn the pet over to the proper authorities. We accept cash , checks, credit, and debit cards.
